REGULATIONS

on holding an online contest of drawing "The Caspian Sea through the eyes of youth" in the framework of cooperation between universities of Caspian region countries

1. General Provisions

1.1. In the framework of cooperation between the universities of Caspian region countries, an online drawing contest "The Caspian Sea through the Eyes of Youth" is being held in conjunction with the "Caspian Day" (hereinafter - the Contest).

Contest Concept

The contest is organized to update the current problems of the Caspian Sea: sea pollution, poaching, changes in natural biogeochemical cycles, etc.

1.2 The organizer of the competition is Kh.Dosmukhamedov Atyrau University, Republic of Kazakhstan.

1.3 Aims and objectives of the Contest: to enrich and fill the process of international and cultural-moral education, creative development of personality and harmonization of students' thinking, knowledge of human relations with reality and nature.

We want to involve university students in the study of this topic through creative activities.

2. Organization of the Contest

2.1 The Contest Organizing Committee (hereinafter referred to as the Contest Organizing Committee) shall manage the preparation, conduct and information of the Contest participants.

- 2.2 The Contest Organizing Committee shall approve the Contest's Jury. The Jury shall determine the winners from the Contest participants.
- 2.3. The Contest jury shall be formed from well-known members of the Union of Artists of the Republic of Kazakhstan.

2.5. By sending an application for participation in the Contest, the author agrees to the terms and conditions of the Contest as set out in these Regulations, and gives the Organizing Committee the right to place the participant's drawings on the official website of the Contest and publish texts about the Contest in articles and press releases without paying any copyright fee.

By taking part in the Contest, the Author gives his consent to the Contest Organizer for recording drawings on video media, replication and publication of which shall be carried out on a non-commercial basis in order to popularize and promote the ideas of the Contest without paying any copyright fee.

3. Conditions of participation and dates of the Contest

- 3.1. The Contest is open to all interested students of the universities that are members of the Association of State Universities of Caspian Region Countries.
 - 3.2 Dates of the Contest:
- The Contest shall be held from July 27 to August 10, 2020;
- Applications for participation are accepted from July 27 to August 7, 2020;
- The final results will be announced on August 12, 2020.

4. Procedure of the Contest

- 4.1 To take part in the Contest, you must submit it to the Organizing Committee:
 - 1. An application of the established form (Annex N_2 1).
- 2. No more than three drawings shall be submitted for participation in the Contest. The Contest entrants' works may have both architectural and landscape character, as well as genre character, tell about people who live in the Caspian Sea region. The main thing is that we want students to be able to see the world around them in an interesting way and to reflect it figuratively in their works.

To participate in the contest we accept works on any paper medium of at least A4 format using any technique - watercolor, gouache, pastel, etc., only in scanned

electronic form. Pictures <u>created in electronic graphic editors are not accepted for participation</u> in the Contest.

- 4.2 Contest entries are accepted to the following e-mail address: g.dauletova@asu.edu.kz, in the subject of the letter it is necessary to specify: country_university_name of the Contest. For example: Republic of Kazakhstan _ Atyrau University Caspian Sea through the eyes of youth.
 - 4.3. Evaluation criteria:
- author's originality of the drawing;
- correspondence to the theme of the contest.
- 4.4. On August 12, 2020, the Contest results will be posted on the official website of the Atyrau University and on Internet portals.
 - 4.5. The Organizer ensures:
- equal conditions for all contestants;
- information support for the Contest;
- conducting the Contest, viewing and evaluation of the Contest participants' works;
- awarding the Contest winners*.

*Winners of the Contest from foreign countries will be nominated by Diplomas and invited for 3 days in Atyrau to visit Atyrau University and the sights of the oil capital (at the expense of the inviting party) after opening the borders between our countries. The winners of the Contest from the AU and Kazakhstani universities will be nominated with Diplomas and valuable prizes.
